Summary of the lecture by resource person on World Day against

Child Labour

The resource person's lecture was in three phases; Trends, causes, consequences of child labour and about legal actions taken by the Government to control the issue.

While talking about causes, Dr Jayashree, the resource person spoken about caste, race, joint family, poverty are some of the responsible causes for the prevalence of Child Labour in the society and because of pandemic it is again newly emerging as social problem. She spoke about the three age groups of population that is Children, Youth and Aged group. The guest speaker also explained the definitions of Child Labour by ILO and UNICEF. She spoken about the total number of child labours throughout the world and BIMARU states in India having more number of child labours referred the working places of them for e.g. garages, selling fruit and vegetables on the streets and agricultural works.

The guest emphasised on the fact that poverty, illiteracy and unemployment are supportive reasons for child labour but direct causes for it. Higher fertility leads to higher poverty and obstacles in the way of child's education, then results in illiteracy. 2 – 14 is an unproductive population but for poor illiterate people children are economic assets, so sends them to work and earn but not for school. Lack of awareness among people about gravity of problem, is also one of the reason for child labour.

The resource person drawn our attention towards other social causes like, single parent families, broken homes e.g. separated and divorced parent, alcoholic and deserted parent, for child labour. Rural – Urban migration is also one of the important reason because

when rural people migrate towards cities and if they don't find work, leads to child labour. Lack of employment opportunities after receiving education, increases the problem more.

Trends: as social problem, child labour has increased very rapidly. 8.4 million Child labours added in last four years. According to ILO and UNICEF the period 2019 and 2020 is reversing time, means the problem has become as serious as it was earlier. According the Global Estimates in 2020, child labour may reach to 46 million by 2022.

The pandemic related reasons like; lockdowns, closure of schools, migration, and children have lost interest in studies. Moreover the poor people are unable to learn from smart phones and internet, face to face teaching is different than the teacher is on screen. Therefore there is increase in child labour the ILO said. In future there will be remarkable increase in child labours particularly in India.

The guest speaker again remind us the definition of ILO, the child labour deprives the child from learning skills and languages and it destroys the child's mental and physical health, it deprives them from playing enjoying and destroy potentialities of the children involved in labour at an early age. The underage like seven, ten, and twelve and fourteen years children are engaged in earning process leads to health problems. For example children working with late machines, mines, welding, beedi rolling and industries creates many health problems for them.

The resource person also drew our minds towards some other grave problems related to child labour. Like Child Trafficking, Child Abuse, Sexual exploitation, Child Pornography and Beggary are closely related to child labour. They become victims for deprivation

of food and atrocities. HIV infection is often very high among child labours. Sometimes rejection by the family, friends, relatives and neighbours leads to child labour. Finally the guest spoke about the legislations, laws and Acts introduced by the Government to control child labour.

The laws and Acts are: Factories Act 1948, Mines Act 1952, The Child Labour (prohibition and regulation) Act 1986, Right to Children for Free and Compulsory Education Act 2009 and Juvenile Justice (care and Protection) Act 2015. These are some of the important Acts adopted by the law to reduce and control the serious problem of the country child labour.
